# A letter from Haverhill Bank President Thomas L. Mortimer



Dear Fellow Depositors,

t is my pleasure to announce that Haverhill Bank reported asset growth of 5.50% and deposit growth of 2.0% in 2019. The bank ended the year with \$415.9 million in assets, an increase of \$21.6 million. Deposits grew by \$6.8 million to \$343.8 million and loans grew by \$7.9 million to \$302 million. In addition, the Bank's surplus grew by \$5 million to \$46.5 million, resulting in a healthy 11.2% surplus to asset ratio.

We continue to grow our online services, including online account opening, while maintaining local, in-person service at our branch locations. On the mortgage side, we invested in talented personnel and technology as we improved our online mortgage application program.

Lastly, I am extremely proud to report that in 2019, Haverhill Bank re-invested over \$300,000 back into the communities it serves by supporting local non-profit organizations and charities. In addition to monetary contributions, employees donated countless hours of their time to serve on the boards of these organizations and volunteer at community events and fundraisers on behalf of the bank.

On behalf of all of Haverhill Bank's employees and its Board of Directors, I want to thank all of the bank's customers for their business and their trust.
